Obscene and Harassing Calls

Every person who, by means of telephone communication, shall:

- (a) Make any comment, request, suggestion, or proposal that is obscene, lewd, lascivious, filthy, or indecent; or
- (b) Make a telephone call, whether or not a conversation ensues, with the intent to abuse, threaten, or harass any person at the called number; or
- (c) Cause the telephone of another to repeatedly ring, with the intent to harass any person at the called number; or
- (d) Make repeated telephone calls, during which conversation ensues, solely to harass any person at the called number; or
- (e) Play any recording on a telephone, except for informational recordings (such as weather or sports updates), without identifying the person or group playing the recording and stating it is a recording; or
- (f) Knowingly permit any telephone under their control to be used for any of the purposes mentioned above,

shall be guilty of a misdemeanor. Upon conviction, they may be punished by:

- A fine of up to \$2,500
- Confinement for up to one year in the county jail
- Or both such fine and confinement

Intent to Defraud

It is unlawful for any person to obtain or attempt to obtain, by use of any fraudulent scheme, device, means, or method, any telephone or telegraph service, or to transmit a message, signal, or other communication by telephone or telegraph, with the intent to avoid payment of lawful charges.

Any person who violates this statute is guilty of a misdemeanor and, upon conviction, may be punished by:

- Confinement in the county jail for up to one year
- A fine not exceeding \$1,000
- Or both such fine and confinement

Special Services for the Hearing & Speech Impaired

WHAT IS KANSAS RELAY?

Kansas Relay is a public service that ensures all citizens have access to prompt, professional, and accurate communication through the telephone. It serves individuals who are deaf, deaf-blind, hard of hearing, or have difficulty speaking. Using services such as TTY, Voice Carry Over (VCO), Hearing Carry Over (HCO), Speech-to-Speech (STS), Spanish Relay, and Captioned Telephone, users can easily connect with family, friends, or businesses.

HOW DOES KANSAS RELAY WORK?

To use Kansas Relay, dial 711 or the appropriate toll-free number. A qualified Communication Assistant (CA) will ask for the area code and number of the person you wish to call and will facilitate the relay. The CA will typically voice the message from the text telephone (TTY) user and type your spoken message to the TTY user.

CAPTIONED TELEPHONE:

Captioned Telephone is designed for individuals with hearing loss who can still speak for themselves. This service allows users to listen to the conversation while reading word-for-word captions of what is said to them.

SPEECH-TO-SPEECH (STS):

STS is a valuable service for people who have difficulty speaking or being understood on the phone. A specially-trained CA, familiar with diverse speech patterns, will assist in facilitating the conversation.

SPANISH RELAY:

Kansas Relay provides access to all relay call types for Spanishspeaking users. If both you and the person you are calling are in Kansas, calls can be translated between Spanish and English.

ACCESS TO SERVICES

Both 711 and the toll-free numbers provide access to the same relay services at no cost. If you have trouble reaching Kansas Relay via 711, contact Kansas Relay Customer Care. All Telecommunication Relay Services (TRS) and English Captioned Telephone services are available 24/7. Spanish Captioned Telephone is available daily from 7:00 a.m. to 11:00 p.m. CST. By law, all conversations are handled with strict confidentiality.

SPECIAL POINTS OF INTEREST:

• Equipment Distribution Program

The Kansas Telecommunications Access Program offers amplified phones, TTYs, Voice Carry Over (VCO) phones, Captioned Telephones, and other equipment to eligible individuals in Kansas who are deaf, deaf-blind, or who have difficulty with speech, mobility, or cognitive abilities. • Emergency Calls

Please note, 711 is only for accessing Kansas Relay services. In an EMERGENCY, continue to use 911. The Americans with Disabilities Act (ADA) mandates that 911 centers are equipped to handle emergency TTY calls.

Although Kansas Relay will assist in emergencies, relay centers are not 911 centers and do not assume responsibility for emergency calls.

TELEMARKETER LAW

TELEMARKETERS MUST OBEY STATE AND FEDERAL LAWS WHEN CALLING KANSAS RESIDENTS.

Violations can be enforced by the state Attorney General or through a private cause of action.

Telemarketers who make unsolicited calls to residential phone numbers MUST:

- Identify themselves, the business they represent, and the purpose of the call immediately upon making contact.
- Promptly end the call if the person indicates a desire to not listen or wishes to stop at any time during the call (i.e., "just say no").
- Have a live or recorded voice respond within 5 seconds of the call being answered.
- Make their phone number visible to caller ID services if technically possible.
- Maintain internal "do not call" lists and, if requested, place the person on this list and honor the request.
- Disclose whether the seller has a policy regarding refunds, cancellations, exchanges, or repurchases.

TELEMARKETERS MUST NOT:

- Use automatic telephone dialing systems or pre-recorded voice messages to call pagers, wireless phones, or any service that charges the called party.
- Send unsolicited advertisements to fax machines.
- Use threats, intimidation, profane, or obscene language.
- Cause any phone to ring repeatedly or continuously to harass the person being called.
- Call before 8:00 a.m. or after 9:00 p.m. local time.

Exceptions:

- Calls placed for non-commercial purposes.
- Calls made for commercial purposes that do not include unsolicited advertisements.
- Calls to individuals with whom the caller has an established business relationship.
- Calls from tax-exempt nonprofit organizations.

Reducing Unwanted Telemarketing Calls

Register for the Direct Marketing Association's Telephone Preference Service (DMA):

You may register your residential phone number(s) with the DMA's Telephone Preference Service to be placed on their "Do Not Call" list. This list helps DMA-member telemarketers avoid calling numbers that do not want to receive telemarketing calls. Registration lasts for up to five years. If you move or change your phone number within that period, you'll need to reregister.

Registering with the Telephone Preference Service will not eliminate all telemarketing calls, such as those from nonprofit/charitable organizations, political groups, non-DMA telemarketers, or businesses with whom you have an established relationship. Since the list is updated quarterly, it may take several months for you to notice a reduction in unwanted calls.

Important Note:

There are no penalties for telemarketers who call numbers on the DMA's "Do Not Call" list, and registering for this list does not grant you additional rights beyond those provided by law.
